List of Maximum Tolls payable in 2008

Arising from the recently announced increase in VAT which is applicable from 1st December 2008, the following revisions are made to the Maximum Tolls payable in 2008:

M1 Motorway (Gormanston to Monasterboice)

Goods Vehicles with a design gross vehicle weight exceeding 3,500 kilograms and having 2 or 3 axles **€4.60**

M4 Kinnegad – Enfield – Kilcock – Motorway

Motor cars **€2.80**

Buses or Coaches **€4.20**

Goods Vehicles with a design gross vehicle weight not exceeding 3,500 kilograms **€4.20**

Goods Vehicles with a design gross vehicle weight exceeding 3,500 kilograms and having 4 or more axles **€6.80**

N8 Rathcormac/Fermoy Bypass

Goods Vehicles with a design gross vehicle weight exceeding 3,500 kilograms and having 2 or 3 axles **€4.60**

The above toll charges are inclusive of VAT at 21.5% and have been rounded to the nearest 10 cent in accordance with the applicable bye-laws.
